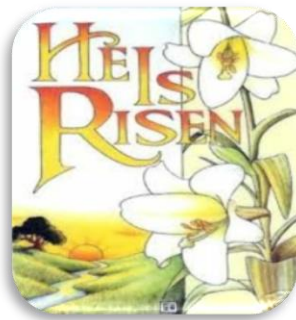
SAVE the date for the LAOH's 75th Anniversary on September 20th at Blue Blinds in Smithtown. More information to follow.
